

# **AUCKLAND FACTS**

Auckland, based around 2 large harbours, is a major city in the north of New Zealand's North Island. In the centre, the iconic Sky Tower has views of Viaduct Harbour, which is full of superyachts and lined with bars and cafes. Auckland Domain, the city's oldest park, is based around an extinct volcano and home to the formal Winter gardens. Near Downtown, Mission Bay Beach has a seaside promenade.

Auckland has a population of over 1.2 million, approaching one third of New Zealand's entire population.

Auckland City lies between the Hauraki Gulf of Pacific Ocean to the east, the low Hunua Ranges south-east, the Manukau Harbour to the south-and the Waitakere Ranges and smaller ranges to and north-west.

- The Harbor Bridge in Auckland has 8 lanes and the central barrier in the bridge is moveable.
- The largest volcano located in Auckland is in the Rangitoto Island.
- According to recent studies, the city's population is expected to grow over 50% in the next 50 years.
- English is the official language spoken in the city. However, since this place is largely Polynesian, a large number of other languages such as Asian and Maori languages are also spoken widely.
- Auckland is located on and around an isthmus, with its narrowest point merely 2 kilometers in width, which is between Mangere Inlet and the Tamaki River.
- As per 2006 statistics, Auckland ranked 23rd on the UBS list of the world's richest cities.
- With regard to the quality of life, Auckland currently ranks 5th amongst 218 major cities of the world.
- There are over 800 restaurants in Auckland.
- Auckland has a perfect, 100 km of coastline and is home to some of the most stunning beaches in the world.

# **AUCKLAND ECONOMY**

Provisional figures released show Auckland's regional economy increased in value from \$95.3 billion to \$101.4 billion between March 2016 and March 2017 (an increase of 6.3 percent).

The increase was driven by strong rises in the rental, hiring, and real estate services; construction; and finance and insurance services industries. However, the 2017 increase is smaller than last year's increase, when Auckland's regional economy rose 7.8 percent.



Auckland's top 18 industries are each valued at more than \$1 billion. It is by far the largest regional economy in New Zealand – the next-largest is Wellington, which is valued at \$35.6 billion. Auckland's share of the national economy is 37.5 percent.

# AUCKLAND -TRANSPORT

Auckland's public transport is a great way to get around. It's easy to travel by train, bus or ferry throughout the inner city and the wider region, with regular routes to most major attractions and our main shopping, dining and entertainment precincts.

#### **Buses:**

Link bus services are a convenient and cheap way to get around Auckland's city centre and inner suburbs — including top shopping and dining spots. They run very frequently, so there's no timetable, and fares start at just 50 cents. Just look for the red, green or amber buses and wait at a matching bus stop.

# Hiring a vehicle:

With an excellent motorway network, driving is a popular choice for anyone keen to discover more of Auckland and New Zealand. Most major rental car companies have depots at Auckland Airport and in central Auckland.

You can legally drive in Auckland and New Zealand for up to 12 months per visit, with either a current driver's licence from your home country or an International Driving Permit (IDP). # **ABOUT MOUNT WELLINGTON AUCKLAND**

Mt Wellington is a suburb of Auckland. It is located 10 kilometres southeast of central Auckland and is bordered by Tamaki, Panmure, Penrose, Ellerslie and Sylvia Park. Mt Wellington was named after the Duke of Wellington. For centuries the local Māori used Mt Wellington as a pa, or fort. nce the Europeans had settled into the area, they began to quarry the lava flow from the Mt Wellington volcano so that this could be used for industrial purposes. Today the old

quarry has been demolished and the area is currently being redeveloped as residential housing. Mt Wellington is a quaint suburb with access to a supermarket and a few shops within the suburb. Nearby Sylvia Park provides a wide range of dining opportunities as well as the Sylvia Park Mall, which contains ample shops as well as a food court. Hamlin Park and access to the Panmure Basin are close by.

# **CHRISTCHURCH FACTS**

Christchurch is a garden city on the east coast of New Zealand's South Island, set on the Canterbury Plains. Flat-bottomed punts glide on the Avon River, which runs through the city centre. On its banks are cycling paths, the green expanse of Hagley Park and the Christchurch Botanic Gardens. In 2010 and 2011, 2 major earthquakes destroyed many city-centre buildings, and restoration work continues.

Founded: July 31, 1856

Branch: South Island

Boroughs: Aranui, Bexley, New Zealand, Avondale, Canterbury Sydenham is an inner suburb of Christchurch, New Zealand, located two kilometres south of the city centre, on and around the city's main street, Colombo Street. It is a retail and residential suburb.

Be part of the biggest construction project in New Zealand's history.

A series of earthquakes struck Christchurch in New Zealand's South Island in 2010 and 2011 and a significant section of the city now needs to be rebuilt. The Christchurch rebuild will require an additional 36,000 workers by the time of peak reconstruction in the third quarter of 2013, which presents the region with a huge employment challenge but presents workers with unprecedented employment opportunities.

A recent report released by the Canterbury Employment Skills Board estimates that about 23,900 additional trade's workers will be needed, including carpenters' joiners, painters, plus labourers and concrete and plastering workers. The city will also require a further 12,000 employees to back up the rebuild requirements, including lawyers, accountants and retail and hospitality workers. More than 10,000 houses need to be rebuilt with repairs to a further 105,500 homes. A huge commercial rebuild project is also required which is expected to take at least 15 years to complete.

The rebuilding and repair work on homes is already well underway and the rebuild of commercial buildings in the central city (where the most extensive damage occurred) will commence by mid-2012. This will create huge demand for skilled labour, a demand that will be maintained for some years. A skills shortage list for the Christchurch region has now been established and the list includes occupations that are in demand related to the construction sector. The list includes occupations such as builders, building management-type roles, engineers, professional scaffolders and quantity surveyors among others. One of the key challenges that Christchurch is facing is the shortage of skilled workers that are currently based in the region. Currently there are about 1800 carpenters and joiners, but a further 4800 would be needed at the peak September 2013 period. Likewise, there are currently about 600 painting trades workers but an extra 2700 would be needed during the peak.



# **CHRISTCHURCH FACTS**

- Hagley Park in the centre of Christchurch is the third biggest city park in the world, behind Central Park, NY and Hyde Park, London.
- The resident population of Christchurch City is estimated to be 366,000. It is the largest city in the South Island, and the 3rd largest urban area in the country.
- Christchurch is one of 5 official Gateway cities to the Antarctic since 1900 the city has been and continues to be a base for expeditions.
- The nickname of Christchurch is the "Garden City" owing to its large botanic gardens and central park
- Christchurch still has the oldest bridge in NZ it's located in Victoria Square and is now a walking bridge.
- Christchurch was the location of one of the deadliest natural disasters in the country's history the February 2011 earthquake. 185 people were killed, many more injured, and huge swathes of the city were destroyed.

Following the 2010-2011 earthquakes, Christchurch/Ōtautahi has re-emerged as a vibrant, ever-changing city. On The New York Times's 52 Places to Go, Christchurch ranked no. 2!

# **TRAVEL**

Getting around <u>Dunedin</u> is super easy thanks to the extensive bus network connecting the city centre and even the furthest outer suburbs. Although Dunedin has a history of trains, cable tramlines, ferries and trolleybuses, public transport in Dunedin today is limited to buses, taxis and airport shuttles. Nevertheless, you can still experience a train journey of yesteryears on <u>The Two Dunedin Railways</u> which are more like scenic experiences rather than commuter trains.


Whatever mode of public transport in Dunedin that you decide to take, it is always best to pay with cash to avoid credit card and EFTPOS fees. For public buses in Dunedin, fares are paid either in cash or with a Go Card (see below). Pricing is based on how many "zones" you pass through.

The Go Card is a way of paying for Dunedin's public transport without rummaging for change. More to the point, the Go Card gives you at least 25% off the fare price. This card is only worth getting if you are planning on staying in Dunedin (and Queenstown) a while, as you have to buy the card for NZ\$5 and be topped up with a minimum of NZ\$10.

All you need to do with the prepay smart card is load it up with some money and swipe your way on and off the Dunedin buses on the electric card readers.

You can buy and load up your Go Card at any Dunedin urban bus (and any Connectabus bus in Queenstown), from the Dunedin City Council Customer Service Centre in the Octagon, the Otago Regional Council office at 70 Stafford Street, Dunedin, and the University Bookshop, 378 Great King Street.



- NZ's largest inland city
- NZ's longest river, the Waikato, flows for 16 kilometres through the city.
- Kirikiriroa, the city's Maori name means "long stretch of gravel"

# PHONES/INTERNET

Mobile phone providers include Vodafone, Spark and 2°. Call & Data plans are very competitive and can be accompanied by free offers for Spotify & TV streaming services. Basic handsets are very cheap, with high-end manufacturers such as Apple & Samsung being the most expensive. For around \$100 a month you would expect to receive a Samsung S7 with 7.5GB date per month and unlimited talk & texts. This can be discounted further if you have additional services such as broadband and landline through the same provider. This is just an example, and cheaper and more expensive options are available.

In terms of broadband speeds, there is Fibre Optic available in high-density areas, with ADSL in the more remote regions. There is rural broadband available in those certain areas, but those speeds and reliability will not be as good.





# **CARS**

It is recommended you have a reliable vehicle to get to work.

Fuel prices are reasonably low presently, hovering around the \$1.80 per litre mark. They were on average \$1.55 in 2010, and it is usually cheaper than most countries. In terms of running your own car, insurance is not compulsory, although highly recommended.

A Warrant of Fitness (WOF) is the equivalent of a MOT & costs around \$50, but the frequency depends on the age of the car. For a car less than 10 years old, it is conducted once a year,

whereas a car older than 10 years will need a WOF every 6 months.

The road tax in NZ is called vehicle licensing, although it is often referred to as 'rego'. This can be renewed every 3, 6 or 12 months or stipulated as several months of your own choosing, but the cost benefits are made by choosing 12 months. The costs vary on age of the vehicle, fuel type & safety rating, but again it is cheaper when compared to other countries.

# **TRAVEL**

Getting around Wellington's capital city and surrounding districts is made easy with the extensive bus and train network. There are even a few public transport surprises in Wellington including its historic cable car and the trolleybuses in use around the city centre. Wellington's trolleybuses are the last in Oceania and the last to be driving on the left. Impress your mates with that piece of trivia... (Or get completely ridiculed).

To pay for most public transport in Wellington you'll either need cash or the correct stored value card (there are different cards for different operators, but Snapper is used on the most services). Be aware that when changing a vehicle on your journey, there is usually an additional charge unless you have purchased a transfer ticket.

# APPLYING FOR YOUR IRD NUMBER SVR POWER LTD

Your IRD (Inland Revenue Department) number is used for all your tax, entitlements and personal details that Inland Revenue holds.

#### **CREDIT CARDS WITH 'SMART CARD' TECHNOLOGY**

Smart cards are payment cards that carry an embedded microchip allowing them to store encrypted, confidential information, and carry multiple applications from different industries alongside debit, credit, or prepaid payment applications. Please note these cards, which often have no magnetic strip, are generally accepted anywhere in New Zealand that has credit card facilities.



#### 7. TAXES



Tax is one of those inescapable facts of life, even in New Zealand. At least however the authorities here have developed a tax system that's comparatively easy to navigate.

#### Key features of New Zealand's tax system include:

- no inheritance tax
- No general capital gains tax, although it can apply to some specific investments.
- no local or state taxes apart from property rates levied by local councils and authorities
- no payroll tax
- no social security tax
- no health care tax, apart from a very low levy for New Zealand's 'accident compensation injury insurance scheme

#### Will you need to pay tax in New Zealand?

The short answer is 'yes'. Income tax and Goods and Services Tax (GST) are how we fund services for the benefit of all New Zealanders.

Not everyone in New Zealand needs to put in a personal tax return, but it is up to you to find out if you need to. If you have overseas income, or arrived part way through a tax year, you are required to file a return. The tax year runs from 1 April to 31 March. There are other circumstances under which you must file a return, check them out on the Inland Revenue website.

So, in practice, most new arrivals need to file a return in their first year here.



#### **8. TAXES CONTINUED**

#### **International customers**

If you hold a temporary visa, or a resident visa and have not lived in New Zealand for the last 12 months you are an international customer.

Your IRD (Inland Revenue Department) number is used for all your tax, entitlements and personal details that Inland Revenue holds.

- 1. Activate your bank account at the bank as soon as you land in country
- 2. Print, sign and date your IRD Form
- 3. The office team at your new company can help you print
- 4. Talk to the office team at your new company, they will send your IRD Form to Inland Revenue NZ
- 5. You will receive your IRD Number by email within 24 48 hours

If for some reason you can't supply the documents Inland Revenue needs, you can call them on 0800 227 774 if you're in New Zealand or +64 4 978 0779 if you're calling from overseas.

#### 9. HOUSING

Having a place to call home is a big part of feeling settled in a new country, and it can take time to find the one that's right for you and your family.

Even if you plan to buy eventually, it's best to start off by renting. That way you can take time seeing what's available and where you'd like to live before you make a commitment.

The Building and Housing Group within the Ministry of Business, Innovation and Employment (MBIE) gives advice and guidance about all aspects of rental tenancies in New Zealand. This includes a guide to the law which is also available in Chinese, Korean, Arabic, Samoan and Tongan. MBIE also offers a mediation service if you have a dispute over a rental agreement.

#### Where to look

You can find rental properties through letting agents such as real estate agents, or by contacting landlords directly. A popular privately operated website where you'll find lots of rental properties advertised is TradeMe Property. Browsing around this website will give you an excellent overview of rents and the types of property available in the area you're considering.

There's high demand for good places, so it pays to make contact quickly.

As they do in every country, rents depend on the quality, location and size of the property. But to give you an indication, TradeMeProperty reported that across New Zealand, on their site in July 2015 the median rental being asked for a three-four bedrooms in Auckland's was NZ\$550 and for larger or more desirable homes, up to NZ\$750.

When you first rent a place you'll need to pay some rent in advance as well as a letting fee if you use an agent (letting fees are normally one week's rent plus GST). A landlord can ask for a maximum two weeks' rent in advance. You'll also need to put up a bond, usually equivalent of up to four weeks' rent. So you need to be prepared to have to pay up to six weeks upfront.





#### **10. CARS**

It is recommended you have a reliable vehicle to get to work.

Fuel prices are reasonably low presently, hovering around the \$2.40 per litre mark. They were on average \$1.55 in 2010, and it is usually cheaper than most countries. In terms of running your own car, insurance is not compulsory, although highly recommended.

A Warrant of Fitness (WOF) is the equivalent of a MOT & costs around \$50, but the frequency depends on the age of the car. For a car less than 10 years old, it is conducted once a year, whereas a car older than 10 years will need a WOF every 6 months.

The road tax in NZ is called vehicle licensing, although it is often referred to as 'rego'. This can be renewed every 3, 6 or 12 months or stipulated at a number of months of your own choosing, but the cost benefits are made by choosing 12 months. The costs vary on age of the vehicle, fuel type & safety rating, but again it is cheaper when compared to other countries.

#### 15. Driving in New Zealand

You can legally drive in New Zealand with your current drivers licence for 12 months. After that time, you must convert your licence to a New Zealand driving licence which you can do at any time before the 12 months is up. To do this you will need to visit a specialist overseas conversion site.

Because your licence is classed as coming from an exempt country you do not need to sit a theory test. If you have been driving for longer than 2 years and your licence shows that it was issued more than 2 years ago you will not have to sit a practical test either.

The cost of converting your licence if you do not need to take the practical test will be just the admin fee of: \$52.10



If you are needing to take the Practical test you will need to pay the admin fee and also the test fee which overall comes to a fee of: \$112.

An offshore person is someone who:

 is a New Zealand citizen who has been overseas for the last three or more years continuously (and is not currently in New Zealand),

or

 doesn't have a New Zealand residence visa granted by Immigration New Zealand,

or

 has a New Zealand residence class visa and has been overseas for the last twelve months continuously (and is not currently in New Zealand).

If these don't apply then use the IRD number application - resident individual (IR595) form.

**Note:** If you're an Australian citizen present in New Zealand at the time you're applying for your IRD number you will complete an *IRD number application - resident individual (IR595)* form.



#### To apply for an IRD number for you or a child in your care

Use the applicant checklist on page 2 before completing the form and signing the declaration on page 5. If you're in New Zealand take the form with the original and legible copies of supporting documents and photo ID for an "In person verification" to an authorised Inland Revenue agent.

If you're outside New Zealand, and you understand that Inland Revenue can't guarantee that emails won't be intercepted or read while in transit, email to: offshore@ird.govt.nz or post to:

If you're outside New Zealand only send legible copies of supporting documents and photo ID.

If your request is URGENT then clearly state the reason why on a separate piece of paper.

#### To apply for an IRD number for you

You must provide each of the following:

- a form of photographic identification, such as a passport or an overseas driver licence
- proof of your current or most recent previous address, which may include:
  - a utility (eg, electricity or water) statement
  - national identity card or overseas driver licence (if not used as photographic identification)
- proof of your intended activity in New Zealand, see the notes for Question 8 on page 2
- proof of your fully functional New Zealand bank account or proof that customer due diligence has been completed - see the notes for Question 10 on page 2.

#### To apply for an IRD number for a child

If you're applying for a child who is in your care and they're under 16, you must provide the following.

#### For you:

- a form of photographic identification refer to "To apply for an IRD number for you".
- proof of your current or most recent previous address refer to "To apply for an IRD number for you".

#### For the child:

- a document which shows the relationship between you and the child, eg,

#### Question 1 - children under 16

If you're applying on behalf of a child, the IRD number shown here must belong to the person who will provide the relevant documents identifying their relationship to the child. If you're also applying for an IRD number, attach the child's application to your own one.

#### Questions 2-4 - applicant information

- If you're completing the application for a child, enter the child's information in this section.
- If you're completing the application for yourself, enter your information in this section.
- If you're using a preferred name, which is different from your given name, you must provide a document confirming your preferred name.

#### Questions 5 - current postal address

- If for rental property the rental agreement, property purchase agreement or letter from your tax agent confirming activity.
- If for employment your work visa or letter of employment on the employer's letterhead.
- If for a student loan the acceptance letter from the tertiary institution.
- If a director or shareholder of New Zealand registered company a copy of New Zealand Companies Office register or letter from your tax agent to confirm activity.
- If a partner in a partnership the partnership agreement or a letter from your tax agent confirming activity.
- If a trustee of a trust the trust deed or a letter from your tax agent confirming activity.
- If "other", proof of activity or letter from your tax agent confirming activity.

#### Question 9 - Taxpayer identification number

If you have a taxpayer identification number (TIN) in another country/jurisdiction outside of New Zealand or as well as New Zealand, you will need to show your most recent TIN and the country/jurisdiction it applies to. #### Customer due diligence by a New Zealand reporting entity

To prove customer due diligence the NZ reporting entity can complete question 10b on this form, or give you a letter confirming customer due diligence has been completed in accordance with the Anti-Money Laundering and Countering Financing of Terrorism Act 2009.

Customer due diligence must be completed by a NZ reporting entity. The Department of Internal Affairs, the Financial Markets Authority and the Reserve Bank of New Zealand provide lists of reporting entities.

## Question 11 - temporary tax exemption on foreign income (complete this question if you continue to receive income from overseas)

You qualify for a temporary tax exemption on foreign income for four calendar years (up to 49 months) if you meet both these requirements:
